
- Do not expose the remote control to water or other liquids. Should the remote control become wet, wipe it dry immediately.

## **Connections with the Personal Computer**

• The projectors native resolution is 1024 X 768 pixels XGA,scalable to 1280 X 1024 pixels SXGA.


Note that input of a resolution that exceeds the displayable resolution will cease to be projected and should this be the case, you will need to change the resolution to a displayable resolution on the computer.

• The setting method of the personal computer will differ depending on the personal computer that you are using. For more information, read the instruction manual for your personal computer, or contact the manufacturer of your personal computer.



## **Connections with Video Equipment**

Component cable (Available as an option) (3.5 mm diameter, 4 Pde, Plug to RCA X 3)


- This projector's video cable and S-video cable are unique cables. To purchase extension cables, please contact your dealer.
- The AUDIO jack of the projector is a 2.5 mm diameter stereo mini jack. Connection is not possible using the common (3.5 mm diameter) stereo mini jack cable from the headphone jack of the personal computer or video equipment.


## **Operating the Projector**

- 1 Set up the screen and the projector See the affixed "Projection Distance Table" for the desired distance between the screen and the projector.
- 2 Connect the personal computer or video equipment to the projector.
- **3** Connect the AC IN connector of the projector and the power outlet using the supplied power cable.

The POWER indicator will light amber, the cooling fan will rotate at low speed, and the unit will enter the standby mode.



4 Switch the projector power on. Main unit operation: Press and hold the POWER button for several seconds. Remote control operation: Press the POWER ON button.



The POWER indicator changes to a flashing green and lights steadily after about 60 seconds. The projection screen brightens after about 40 seconds.

The projector is now capable of regular projection.

- **5** Switch the power of the connected equipment on.
- 6 Select the input


Main unit operation: Press the SOURCE button.

Remote control operation: Press the desired button from among the input selection buttons.


## **Turning the projector Off**

**1** Switch the power button off.

**Main unit operation:** Press and hold the POWER button for several seconds. **Remote control operation:** Press the POWER OFF button.




The "Power off" indication will appear. When the red bar extends fully (approximately 5 seconds), the projection screen will turn off and the unit will enter the power off operation.



#### Note

- The operation can be cancelled by pressing a button other than the POWER button.
- One more press of the POWER (POWER Off) button will switch off the power.



2 Unplug the power cable. Check that the POWER indicator is lit amber and then unplug the power cable. The POWER indicator will go off when the power cable is unplugged.

#### WARNING:

Do not unplug the power cable while the POWER indicator is flashing amber. Doing so may shorten the life of the lamp or damage the projector.

## **Using the Quick Menu**

Note that the Quick Menu will not be displayed unless the signal of the connected equipment is detected. Please select the input that you wish to adjust.

#### Main unit operation

- (1) Press the QUICK MENU button to access the Quick Menu. Press again to select the desired adjustment display.
- (2) Press the  $\triangleleft$  or  $\triangleright$  button to adjust.
- (3) To close the display immediately, press the MENU button. In the absence of operations for a period of about 10 seconds, the display will close automatically.


#### **Remote control operation**

- (1) Press the QUICK MENU button to access the Quick Menu. Further presses cause the adjustment display to change in sequence. The adjustment display can be selected with use of either the cursor ▲ or ▼ button.
- (2) Press the cursor  $\blacktriangleleft$  or  $\blacktriangleright$  button to make the adjustment.
- (3) To close the display immediately, press the CANCEL button.In the absence of operations, the display will close

automatically in a period of about 10 seconds.



Brightness	Adjusts the brightness of the image.	
Contrast	Adjusts the contrast of the image.	
V Keystone	Corrects (vertical) keystone distortion of the screen. Adjusts the left and right edges of the screen so that they are parallel.	
H Keystone	Corrects (horizontal) keystone distortion of the screen. Adjusts the upper and lower edges of the screen so that they are parallel.	
Picture in Picture	The picture from the VIDEO jack is displayed as a sub-picture on the input screen from the PC connector. This function selects either the size of the sub-picture (i.e. large, medium, or small) or off (i.e. no display). ## **Menu Operation**

### **Remote Control**



#### **MENU** button

Used for menu display and menu closure.

#### CURSOR(▲▼◀►) button

Selects menu names and item names as well as in setting and adjusting the item contents.


#### **CANCEL** button

Returns to menu name selection as well as to close the menu (and the sub menu display).

#### **ENTER** button

Sets the verification display.

### Projector



#### **MENU** button

Displays menu, to return to menu name selections, and to close menus (i.e. closing sub menu displays).

#### ⊳(AUTO) button

Advances the selection of menu names. Advances the setting/adjustment values of the item contents. Also serves the function of the remote control ENTER button.


#### **∏(QUICK MENU)** button

Selects of item names.

#### (SOURCE) button

Returns to the selection of menu names. Advances the setting/adjustment values of the item contents.

### **On Screen Display**



- The remote control should be pointed toward the remote control sensor of the projector and operated.
- When no signal is detected, only "Color", "Setup", and "Info." can be selected. ("Color" can be selected for Video and S-Video source only.)
- The menu will close automatically if no buttons are pushed within 30 seconds.

#### Menu Display

- 1 Press the MENU button to display the menu
  - **Note :** Pressing the main unit MENU button will change the function of the SOURCE button, AUTO button, and QUICK MENU button to that of cursor buttons.

#### **Menu Selection**

2 Press the cursor (◄►) button to select the menu item you wish to adjust.
 Each press of the cursor (►) button advances the selection one step in the sequence of "Color" → "View" → "Setup" → "Info." → "Image".

Each press of the cursor  $(\blacktriangleleft)$  button causes a return of one step. The selected menu name will appear in red.

**Note :** To cancel the display of the cursor, press the CANCEL button on the remote control or the MENU button on the projector.

#### **Displaying the Cursor**

**3** Press the cursor  $(\mathbf{\nabla})$  button to display the cursor.

#### Selection of the Item Name

4 Press the cursor  $(\blacktriangle \nabla)$  button to align the cursor with the item name.

**Main unit operation:** Press the  $\bigvee$  (QUICK MENU) button. When the cursor has moved to the very bottom of the items

very bottom of the items, another press will move it to the very top of the items.

When the  $\blacktriangleright$  icon is displayed and depending on the item contents, a press of the cursor ( $\blacktriangleright$ ) button will result in the sub menu, the setting display, a resetting of the adjustment value, or a resetting verification display.

#### Making Adjustments/Settings


5 Press the cursor (◄►) button and make the adjustment (or setting) while viewing the image. When a button is pressed, the image will also change.

#### **Closing the Menu**

6 Press the MENU button and close the menu display.

**Main unit operation:** Press the MENU button and delete the cursor. The operation will differ depending on the display contents when a sub menu is displayed. Should a sub menu be displayed, press the MENU button until the MENU display closes.

Should this happen, wait one minute and then switch the power on again.
Flashes red (1 s lit / 1 s off)	When the lamp burns out during operation: Flashes amber for 90 sec- onds and then stays lit When the lamp does not turn on: Lit amber	The lamp will not turn on Wait one minute or longer while the lamp lighting voltage irregularity detection protector is activated and switch the power on again. If the problem still persists, unplug the power cable and contact ViewSonic.
Flashes red (0.5 s lit /0.5 s off)	Lit amber	The fan has stopped. Unplug the power cable and contact ViewSonic.
Flashes red (1 s lit / 1 s off)	Lit red	The lamp cover is open. The lamp cover is not attached properly. Attach it properly.
Lit red	Lit amber after 90 seconds of flash- ing in amber	The lamp will not turn on. The lamp has reached end of life. Contact your reseller or ViewSonic for a replacement lamp.

#### Note:

Should the projector not project properly, see the Troubleshooting section of the User Guide.

## **Replacing the Lamp Cartridge**


### 

- The Lamp Cartridge should only be replaced after the unit has been turned off, cooled down for 60 minute and the power cord has been unplugged. Replacement of the lamp cartridge during operation or immediately after operation stops may cause burns due to high temperature.
- Do not remove any screws other those specified.
- Do not touch the lamp with bare hands. Doing so could shorten the life of the lamp.
- If the lamp has reached the end of its usable life, the lamp bulb may shatter. If the lamp shatters, contact ViewSonic Customer Support center immediately.

#### PREPARATION

To prevent scratches place the lamp on a soft cloth.

- **1** Disconnect the power cable.
- 2 Turn the projector upside down.
- **3** Remove the lamp cover.
- (1) Turn the screw that fastens the lamp cover counterclockwise until it turns freely. (The screw will not come out.)




(2) Lift the lamp cover a little and pull it off in the direction of the arrow.

#### 4 Remove the lamp cartridge.

(1) Turn the 2 screws that fasten the lamp cartridge counterclockwise until they turn freely. (The screws will not come out.)

(2) Grasp the handle of the lamp cartridge, pull it upward and remove the lamp cartridge.



#### **5** Install the new lamp cartridge.

- (1) Slowly push in the lamp cartridge with the socket facing forward. (Align the lamp cartridge screw with the screw hole of the projector.)
- (2) Turn the 2 screws of the lamp cartridge clock-wise to tighten.

#### 6 Install the lamp cover.

- (1) First insert the front edge of the lamp cover into the groove, then close the lamp cover.
- (2) Turn the screw of the lamp cover clockwise to tighten.

#### 7 Reset the lamp timer to zero.


Plug in the power cable and switch on the power before resetting. Select [Info.]  $\rightarrow$  [Lamp Timer Reset] and then reset the hours indication.



#### What the warranty covers:

ViewSonic<sup>®</sup> warrants its products to be free from defects in material and workmanship during the warranty period. If a product proves to be defective in material or workmanship during the warranty period, **ViewSonic** will at its sole option repair or replace the product with a like product. Replacement product or parts may include remanufactured or refurbished parts or components.

#### How long the warranty is effective:

ViewSonic projectors are warranted for three (3) years for all parts excluding the lamp and three (3) years for all labor from the date of the first consumer purchase. Projector lamps are warranted separately.

#### Who the warranty protects:

This warranty is valid only for the first consumer purchaser.

#### What the warranty does not cover:

- 1. Any product on which the serial number has been defaced, modified or removed.
- 2. Damage, deterioration or malfunction resulting from:

The power cord set for this unit has been enclosed and has been selected according to the country of destination and must be used to prevent electric shock. Use the following guidelines if it is necessary to replace the original cord set, or if the cord set is not enclosed.

The female receptacle of the cord set must meet CEE-22 requirements and may look like (Figure A1 below):

#### For the United States and Canada

In the United States and Canada the male plug is a NEMA5-15 style (Figure A2), UL Listed, and CSA Labeled. For units which are mounted on a desk or table, type SVT cord sets may be used. The cord set must be selected according to the current rating for your unit. Please consult the table below for the selection criteria for power cords used in the United States and Canada.
